Property description

In Apolpaina, Lefkada, in a quiet and privileged location, just a few minutes from the town, an impressive luxury villa with approx. 460 m² of living space is for sale, consisting of two separate residential units.

The property offers unique panoramic views of Lefkada town, the marina, the lagoon and the Ionian Sea and combines privacy, comfort and direct access to the island's infrastructure in a rare way.

The two residential units with approx. 150 m² and 306 m² of living space have a total of 8 bedrooms, 5 bathrooms, 3 kitchens, spacious living and dining areas and 3 fireplaces.

The architecture combines natural stone, wooden elements and large window fronts to create bright and warm rooms with a direct connection to nature.

The first unit has a living room with fireplace, a kitchen, a dining room, 3 bedrooms, a bathroom and verandas with views. The second and larger house includes a spacious living room with fireplace, a modern kitchen, a dining room, a guest room with en-suite bathroom, three bedrooms each with en-suite bathroom and a separate master suite with living room, fireplace, private kitchen and verandas.

The house was built in 2011 and is fully furnished and equipped. It has a security door, an alarm system, air conditioning and a heating/cooling system with fan coil unit, offering comfortable living all year round.

The outdoor area is dominated by the large swimming pool, which is surrounded by spacious verandas, relaxation areas and a beautifully landscaped Mediterranean garden with olive trees, fruit trees, fragrant plants and stone paths.

The property also has a parking lot, a paved driveway and is east-facing.
