Property description

In Keri, Zakynthos, on a 4,920 m² private lot with panoramic views of the Ionian Sea, one of the most versatile and comprehensive properties on the island's real estate market is for sale. The house, which was completely renovated in 2025, will be handed over turnkeyfurnished and fully equipped and is ready for immediate occupancy. The complex consists of two separate two-story houses, each containing four 100 m² apartments.

Each building has a ground floor and an upper floor. Each apartment features two bedrooms, two bathrooms, a living room, a kitchen, large windows, and verandas with stunning views of the Ionian Sea. A fifth separate apartment with a bedroom, office, kitchen, and garage is ideal as a primary residence or private retreat. An 80 m² storage room, a machine room, and water tanks ensure complete self-sufficiency.

The design aesthetic is modern and minimalist throughout: marble and tile floors, double-glazed aluminum windows, air conditioning, a solar power system, a boiler, and sound and thermal insulation. Oil-fired heating with radiators in every room. The east-southeast orientation ensures sunshine all day long, and the view of the Ionian Sea with the sunset in the background is one of the location's greatest natural assets. The furnished verandas make the most of this scenery. The outdoor area is what makes this property truly special: a large swimming pool with a hot tub, a well-maintained garden with a lawn and trees, and a terrace with lounge chairs and umbrellas.

The 120 m² multipurpose room, featuring a terrace of the same size, currently serves as a traditional tavern and can be used as an entertainment area or for other purposes as desired.
