Location

Within walking distance are Pantazi Beach, Stoupa with its famous beaches, and Kardamyli. Restaurants, cafés, and shops for daily necessities are also nearby.

Property description

In Agios Nikolaos, in western Mani, a detached stone house built in 2026 with 100 m² of living space is for sale.

It combines the characteristic architecture of Mani with modern design and exceptionally high construction standards.

The house features two bedrooms, two bathrooms, a fully equipped kitchen, and a comfortable living room, with bright and well-maintained rooms.

Natural stone dominates both the facade and select areas inside, creating a modern home that blends harmoniously into the authentic landscape of the Mani. Special emphasis was placed on construction quality and the materials used.

Brand-name materials and high-quality finishes were used, with attention paid even to the smallest structural and aesthetic details. The same philosophy was applied to the furnishings:

The house is delivered fully furnished with select pieces from renowned manufacturers and appliances, creating an all-around high-quality and particularly appealing overall look.

The house features an autonomous heat pump with individual heating controls for each floor, air conditioning, a solar water heater, a boiler, thermal insulation, and a thermally insulated facade.

The aluminum frames with double glazing optimize the building's thermal and energy efficiency.

The outdoor area is dominated by the private swimming pool, bordered by stone and landscaped relaxation areas, while the verandas form a natural extension of the interior spaces. From the upper veranda, there is a magnificent view of the sea and the region's characteristic olive grove landscape.
